#### **DIETARY NEEDS**

We're happy to cater to dietary requirements! However, please note that while we take great care in our food preparation, our kitchen is not certified as nut-free, vegan, or gluten-free, so trace elements may still be present. Bites + Boards Co. cannot accept liability for any reactions due to the disclosure that our kitchen is not specifically registered for dietary requirements.

To accommodate your needs, all dietary requirements must be provided in writing at least 7 days before your event. If we receive less notice, we will do our best to meet your request and will notify you in writing if it is not possible.

Please note, we cannot accommodate dietary requirements shared on the day of or during the event.

#### **DEPOSIT + PAYMENT**

To secure your booking, a 50% deposit is required. The remaining balance due 14 days before your event.

Once an invoice is issued, payment must be made within 72 hours to guarantee your date. If payment is not received within this timeframe, we cannot hold your booking/hold your date.

Quotes and invoices are valid for 14 days and will not incur any price adjustments during this period.

We accept payments via EFT or card. Please note, all card payments processed through our Square payment system will incur a 1.6% surcharge if paid in-person, or 2.2% surcharge if paid online

## The fine print cont'd

#### CANCELLATIONS + REFUNDS

We are unable to provide refunds for change of mind once you have booked and confirmed your event.

Cancellations 30 days or more before your event: You will receive a full refund or the option to use the credit for another date within the next 6 months.

Cancellations between 14–30 days prior: You can choose a refund minus a 25% admin fee or a credit for a rescheduled date.

Cancellations between 7-14 days prior: The 50% deposit is non-refundable. However, a credit may be offered if the event is rescheduled.

Cancellations less than 7 days prior: Unfortunately, no refund can be provided due to the costs of goods, labour, and loss of business.
